Campus Security Report: Grand Prairie

By October 1st of each year Tint School of Makeup and Cosmetology prepares a security report to comply with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act. This report is prepared by Tint management in cooperation with local law enforcement agencies in those areas where its campuses are located. Campus crime, arrest and referral statistics include those reported to Tint authorities and local law enforcement agencies.

Tint gives notification to each student and employee regarding how to access its report on crime statistics. Prospective employees may obtain printed copies of the report by requesting it from the Hiring Manager. Prospective students may obtain printed copies of the report by requesting it from the Admissions Coordinator and/or the School Director. Reporting Crimes

All students and employees are encouraged to report crimes, suspicious activities or other security problems which occur on or near the school property. Criminal offenses should be reported to the administration for the purpose of making timely warning reports and the annual statistical disclosure. Tint's policy allows victims or witnesses to report crimes on a voluntary, confidential basis for inclusion in the annual security report.

School Security Policy

A School Security Force has been appointed to enhance the safety of both the students and the employees. The School Security Force at this school consists of the Chief Security Officer (School Owner) and the Chief School Officer (School Director).

A written report will be made to address complaints made to Security Personnel. In the event that outside help should be called in (i.e. local Police, Sheriff's Department, Federal Officers, etc.), the School Security Force shall cooperate with said agencies and investigations to the best of their abilities, and within the scope of school policies.

The School Security Force has the authority to check all persons on the school property to determine the legitimate presence, and to escort unauthorized person to the proper office or off the school property. While on School property, students are encouraged to avoid being alone in isolated areas, lock vehicles and personal belongings and report suspicious activities or persons.

Certain areas of the School facility are not open to the public and are considered to be restricted. Individuals who wish to visit restricted areas or persons in such areas must first obtain permission through either the admissions officer or the administration office. Visitors to the school classrooms or laboratories must check in with the School Security Force. The School Security Force maintains security during open hours.
